The International Society for the Prevention of Child Abuse and Neglect (ISPCAN) has asked the Kempe Children's Center to gather the information necessary to prepare "WORLD PERSPECTIVES ON CHILD ABUSE: The Fifth International Resource Book." This fifth book in the series will be distributed at the 14th International Congress on Child Abuse & Neglect in Denver, Colorado, U.S.A., July 7-10, 2002.

Because of your past help or because you have been identified as a person who might assist us in this effort, we are enclosing or attaching (for E-mail respondents) a 8 page questionnaire. If you agree to complete this questionnaire and return it to us, your responses will be used in the upcoming 5th edition. We would be pleased to list you as a respondent for your country if you wish, or you can choose to provide information anonymously. However, before we can agree to publish your name as a respondent, we need to have you consider if the information you provide should be published in the 5th World Perspectives on Child Abuse with your name associated as a source. In particular, is there any reason to believe that publishing your responses could reasonably place you at risk for any criminal or civil liability or damage your financial standing, employability or reputation? If the answer to any of these questions is "yes," then under law in the United States we cannot include your name as a source of information, for your own protection. Instead we would put "anonymous" for your country. If you want to be anonymous please do not fill out any information on the questionnaire until you reach "Discipline of Work".

If we do not hear from you by JANUARY 31, 2002, we will assume that you are not able to participate in this survey. If you cannot respond, please pass the survey to someone else willing and qualified.

The publication of an updated resource book will be useful to our field, and we hope you will join us in this worthwhile endeavor. With the data from this survey, we will have six years of survey trend data for the
