Dear Ms. Pérez de Serrano,

I am writing to you with regard to the United Nations Voluntary Fund for Victims of Torture and I wish to refer to my letter dated 26 May 1987 relating to the grant made to the project sponsored by your organization and to the report and accounting submitted by letter of January 1987.

The Board of Trustees has reviewed the report and accounting and would like to thank you for the complete and detailed report you have submitted. The Board also decided to recommend the release of a further grant of US\$ 85,000 for that project for the year 1988. These funds will be transmitted to you in the coming days. The Board wished that the funds so provided be used to assist victims of torture and their family members and in accordance with the terms of our previous letters on this subject.

The Board of Trustees at its seventh session reviewed the prospects for providing assistance to your project in 1989 and it decided to consider favourably a renewal of its support for 1989 subject to the presentation of a report and general accounting on the use of the grant for 1988 and the demonstration of a continuing need. As for years after 1989, the Board asked that you be informed that the evolution of the resources available to the Voluntary Fund and the need of other projects presented to it make it unlikely that the same high level of grants could be maintained after 1989. You may wish to continue your search for other sources of financing.

With regard to the grant for 1988, the Board wanted to receive the same type of report and financial accounting that you have submitted in the past.
